Its coloration might suggest that of a junco, but its habit of sitting in an erect posture, frequent tail-wagging and food capture using unique flycatcher techniques tells us otherwise!

Black Phoebes are common around western farmyards and along streams below 6,000 feet elevation. They are widely distributed in California on the entire Pacific slope west of the Sierra, deserts and along the Colorado River. They may make some seasonal movements into the southwestern portion of the state during fall and winter. Others may move upslope in the mountains during the late summer.

Black Phoebes prefer habitat that is in association with fresh water streams, small rivers, and irrigation canals, along with ponds, lakes, coastal lagoons and quiet tidal pools. Phoebes

like low open perches, and may even utilize rocks in streams. One of the most domestic of western birds, they are also found in suburbs and cities. The flight of the Black Phoebe is a buoyant one with its head raised, its wingbeats below horizontal and short glides taken with the wings pulled in close to its body. The phoebes we have in our back yard seem very attracted to making flights over and dips in our swimming pool!

The Black Phoebe song is a thin strident "fi-bee, fi-bee," just like their name. The first two notes rise and the last two drop and this series can be sung 20-30 pairs per minute! Sometimes the male will also use a thin descending whistle that is about as long as one of the songs. Additionally a sharp "tsip" is also used throughout the year.

Black phoebes nests are well scattered, not colonial. They often return yearly to the same nesting site. Originally they nested in crevices or on ledges near aquatic

habitats. Now they often nest on bridges, culverts, buildings and walls in well-shaded areas near water. An old nickname given the Black Phoebe was "Bridge Phoebe" because of its preference for nesting in over-water structures. Their mud cup nest is constructed using weeds, grasses, fibers and often covered with mosses and lined with finer grasses and hair. Into this 4 ½ inch sturdy cup are laid 3-6 white or dotted eggs which are incubated for about two weeks before hatch. The young leave the nest after an additional two weeks. They can have multiple broods per year and the pairs often mate for life.

Food utilized by phoebes is almost 100 percent animal matter and largely composed of flying insects taken in their flight over streams, meadows, and even residential lawns. Black Phoebes quick closing jaws enable them to capture the fastest insects, including bees, wasps, mosquitos and flies. Phoebes have been seen up to their eyes in water when

chasing a choice bit of food. How fortunate for all of us to have such wonderful insectivorous birds in our midst!
