as warning sounds. Their flight is soundless because of feathers with fluted tips to break up the wind passing over them. They prefer open range or farmland where their prey never hears them coming. They have trouble navigating in wooded areas. We find the barn owl in our area up to about the 3,000 foot elevation in the summer time and lower in the winter as they move down out of the cold to the valley floor.

Barn owls usually eat their prey whole. The teeth, bones, and fur are not digested but collected and coughed up and out of the owl in the form of a pellet or casting. All birds of prey do this.

Rosie helped inform over 10,000 adults and children on the incredible value of the barn owl. She appeared

on the cover and in Audubon Magazine in March of 2004 her final tribute.

rinas, trails and day use areas opened at 8 am on Saturday. Parking was available at the marina and the north shore parking areas; vehicles were also parked alongside Highway 168. Visitors were clearly enjoying themselves, all thoughts of the pandemic having been set aside for the day.

According to Ryan Stewart, Edison registered professional forester and supervisor of the patrol system in place for the holiday, they had prepared for a very large number of people—but it appeared there was a more moderate gathering than expected. Eight Edison employees monitored and patrolled the different parking areas, and checked on the day guests on the beaches to ensure they were following the rules: physical distancing, no charcoal barbecues and no fireworks.

A few of the beach guests who were interviewed said they were disappointed about the fireworks being cancelled, but were determined to enjoy the day and would be up to enjoy the fireworks in 2021.

A couple of Fresno County Sheriff's deputies—Phil Lodge on his horse Duke, and Todd Talent on his horse Ozzie—provided horse pa-

trol throughout the trails to check on people and make sure everything was in order.

Around 7 pm, an hour before closing, boating deputies working on the lake attempted to stop a wave runner on the lake at Road 2 for a boating violation. According to deputy sheriff Scott Weishaar, the wave runner drove to shore and two people fled into a crowd of people. Deputies patrolling on land in the area assisted and attempted to detain the subiects, who resisted and grew hostile. One subject fought with deputies and was taken into custody. In all, four people were arrested and one citation was issued. The remaining crowd of friends were asked to leave the area.
