

watershed, while conserving valuable historic and cultural resources, along with critical wildlife habitat and water resources. The Hornitos Ranch is adjacent to the Merced River and Lake McSwain Public Recreation Area, boasts over three miles of Merced riverbank, 31 miles of streams, nine miles of wildlife corridor, 42 acres of riparian habitat, 146 acres of U.S. Fish and Wildlife designated critical habitat for vernal pool species, 5,084 acres of blue oak savannah and 1,700 acres of annual grassland.

The Hornitos Ranch Conservation Easement addresses statewide conservation issues by preventing fragmentation of working landscapes, future pollution and degradation of air, water and natural resources. The conservation easement held by SFC will permanently ensure the reliability of local water supplies and protect 11 square miles of adaption corridor for native species in the face of a changing climate. The SFC team is tremendously proud of the Hornitos Ranch Conservation Easement and looks forward to celebrating in a traditional easement closing ceremony when the time is right.



The Hornitos Ranch conservation easement comprises 6,972 acres, bringing SFC's total to 44,810 acres conserved.
